# Bakman Water Company water system has levels of 1,2,3-Trichloropropane Above Drinking Water Standards

Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what you should do, what happened, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Testing results from 7/30/21 - 5/31/2022 showed 1,2,3-Trichloropropane (1,2,3-TCP) levels of 0.005 ug/L - 0.007 ug/L. The standard or maximum contaminant level (MCL) for 1,2,3-TCP is 0.000005 milligrams per liter (5 nanograms per liter, or 5 parts per trillion or 0.005 micrograms per liter (ug/L). The average level of 1,2,3-TCP over the last year was 0.0062 ug/L.

#### What should I do?

- You do not need to use an alternative (e.g., bottled) water supply.
- This is not an immediate risk. If it had been, you would have been notified immediately. However, some people who drink water containing 1,2,3trichloropropane in excess of the MCL over many years may have an increased risk of getting cancer.
- If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

## What happened? What is being done?

Bakman Water Company is minimizing the use of well #16. Bakman Water Company has retained an Engineering firm to help design a treatment plant for 123 TCP. Applying for permits to build a treatment plant. We anticipate resolving the problem within a couple of years or sooner if possible.

You can do this by posting this public notice in a public place or distributing copies by hand or mail.

## **Secondary Notification Requirements**

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- SCHOOLS: Must notify school employees, students, and parents (if the students are minors).
- RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS (including nursing homes and care facilities): Must notify tenants.
- BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS: Must notify employees of businesses located on the property.
